What is a Community Foundation?

A community foundation is a collection of charitable funds established by people from all walks of life who have one thing in common - the desire to make a difference in their community, forever,

Donations to endowment funds are pooled together and invested. The income from these investments is then used to make grants to support local registered charities, while the capital remains untouched.

We are often asked how to make a gift to GCF. The Foundation accepts everything from loonies to

legacies. Simple donations to existing funds can be any size.

In spring of 2005, The Guelph Community Foundation received over \$900.000, our largest gift In this issue: to-date, from the late Norman Earl Webb. Mr. Webb worked with his lawyer to create the I. > The Normal Earl Webb Fund has two components, one is a Donor Advised Fund which is a simple, powerful and highly personalized approach to giving, and the other is an Unrestricted Fund, that is apart of our Community Fund where funds are pooled together. Anyone can donate any amount to the Community Fund. In both cases, the gift is endowed, carefully invested and can grow over time. Each year, the interest income is granted out to organizations in Guelph and Wellington County.

> In the Donor Advised Fund we will be working with the late Mr. Webb's granddaughter, where she can recommend uses for the fund to support the agencies and programs that her grandfather was most passionate about. The Unrestricted Fund is a little different, as it will give the Foundation the greatest flexibility to respond to current and ever changing community needs. In both cases, the recommendations are presented to the Foundation's Board of Directors for approval and the Foundation handles all of the administrative details such as receipting, tax reporting, and granting to the selected charities. This gift will benefit the community forever. 3

Support your community and get tax sheltered income

The fall is a great time of year to meet with your tax advisor to consider last minute tax planning ideas. Topics to discuss include RRSP contributions, calculation of capital gains or losses from stocks or other properties, consideration of selling securities that are in a loss position and opportunities for income splitting.

Your discussion should also include the ability to reduce taxes with a well-timed charitable gift. Here are a few considerations to help with your year-end charitable giving.

- The personal tax savings from the first \$200 of donations in a year is about \$45;
- The personal tax savings from annual donations in excess of \$200 (assuming the top marginal rate of tax) is 46.4%. Therefore, a gift of \$1,000 will save about \$460 in tax, reducing the after-tax cost to \$540;
- To make a donation you can write a cheque or you can give assets, such as stocks, bonds, mutual funds, artwork, real estate or even an insurance policy;
- If you donate an asset that has an unrealized gain [meaning the asset is worth more now than when you acquired it] you will need to report a capital gain for tax purposes. However, the tax credit for the market value of the donation should cover any capital gains tax and still give you additional savings;
- If you donate publicly-traded securities, the capital gains tax is even lower, at half the regular capital gains tax;
- A gift must be made by December 31 in order to save tax for 2005. If you intend to give assets [other than cash], you should begin making the plans as soon as possible;

What is the Evergreen Action Nutrition program?

Evergreen Action Nutrition is a nutrition education program that the McNeil Consumer Healthcare Fund is excited to grant funds to this year.

"About half of older adults [aged 55+] continue to be 'at risk' nutritionally. Along with early detection and treatment of disease, adopting healthier diets and more active lifestyles can help to delay the progression of disease and decline in physical health", stated Pat Vanderkooy, Registered Dietitian of the program.

The program offers a variety of services for seniors:

- ✓ Food and nutrition workshops on a variety of topics, geared to the needs of an older adult population;
- ✓ A men's cooking group meets monthly for hands-on cooking experience in a social environment, to increase confidence with food preparation and

more about planning healthy meals;

- ✓ One-on-one nutrition counselling with a Registered Dietitian to address health concerns, physical conditions/diseases and recommended changes in food intake for a healthier diet;
- √ 'Garden Fresh Box'-a monthly depot where fresh fruit and vegetables can be purchased for a lower price. As a part of a community wide initiative, this program addresses the issue of low fruit and vegetable consumption by many seniors;
- ✓ A Diabetes Support Group meets twice per month to share information, recipes and gain new skills on living with diabetes; ✓ And valuable resource information.
- "It helps learning how to cook healthy recipes, now that I'm alone . . . plus I like having lunch with the other men . My appointment with the Dietitian helped me manage my diet

better too", stated a EAN participant. 3
