Will not fund/ Restrictions	<p>-Applications over \$2000 (if pursued need to be considered by County Council)</p> <p>-A number of agricultural societies and groups are exempt from the annual application process and submit a grant letter instead to receive their funding support.</p> <p>-Applications pertaining to the delivery of Social Services or related issues are typically referred to the Social Services Department for consideration. Organizations or groups applying for funding are encouraged to work with staff to discuss their proposal prior to making a request via delegation to the Social Services Committee of Council.</p> <p>-The County will issue RFPs related to Social Services funding/projects. Typical funding scenarios that involve an RFP include:</p> <ul style="list-style-type: none"> -Affordable Housing Capital Projects -Funding allocated through the Federal Homelessness Partnering Strategy (bi-annually) 	<p>Will not fund:</p> <ul style="list-style-type: none"> -Programs that other gov't levels have legislative responsibility to fund -More than \$15,000 per grant -Debt -Retroactive payments -100% of budget activity -Secondary allocations 	<p>- Funded agencies are to abide by a fundraising black-out period (annually between Labour day and Nov. 30th)</p> <p>- No activities soliciting funds (communication/promotion with existing donor base and third party events allowed) all details found here.</p> <p>Other exclusions to program funding:</p> <ul style="list-style-type: none"> - arts and culture - direct sports and recreation - capital campaigns - primary health-based issues - environmental projects/organizations - educational institutions - direct religious activities 	<p>-Religious</p> <p>-Political</p>

Evaluation	Application requests an outline of project activities, impact (County and Township level), as well as budget. Financial statements or operating budget of the organization also requested.	Grant recipients must report on performance measures -How much work was done? -How well was work done? What difference did it make?	Applicants must include agency and program level budgets; must establish outcome alignment with United Way areas of focus; and demonstrate qualitatively and quantitatively an understanding of community need and program impact.	Community Grants -What results were achieved? -What aspects did not turn out as planned? -Were there any unexpected outcomes? -Did your organization create and enhance partnerships? -Will project continue? -Additional comments
Process	-Apply -Applications reviewed and funding recommendation made by the Administration, Finance and Human Resources Committee. Grants approved by County Council (typically February).	-Apply -Staff Review -Volunteer Committee appointed by Council reviews and makes final decision	-Apply -Staff Review -Volunteer Committee (Fund Distribution Committee) reviews and makes recommendation to Board of Directors where final approval is made. All applications are vetted through a sound process involving staff and community volunteers.	-Apply -Staff Review -Volunteer Committee reviews and makes recommendations
